Adding Users

Note that, once allocated to an individual, a Per User licence cannot be reallocated within the licence year. In committing to a 3 year licence this means that you can reallocate Per User licences at the start of years 2 and 3.

Licensees may add licences to those they have already purchased through an initial Order, by means of a subsequent Order. Fees for such additional licences shall be prorated on a monthly basis so that the additional licences shall be co-terminus with the existing licences.
