



Chest Adobe ETLA 2018 Framework Agreement Overview  
August 2019 Joiners

**Important note – the deadline for joining the agreement this year is July 15<sup>th</sup>, 2019 and payment must be received by August 9<sup>th</sup>, 2019 without fail.**

The Chest Adobe ETLA Agreement is a three year subscription agreement (although you will be joining for two years) that allows Institutions to install Adobe Creative Cloud Enterprise Desktop Apps (or Creative Suite 6 under downgrade rights) on the PCs/Macs that they own or operate for use by students. Staff receive the full Adobe Creative Cloud Enterprise edition including cloud services (except Sign and Stock).

Adobe Sign is available as a separate option under this agreement.

At the end of the agreement you will need to renew your licence or remove all the software installed under it.

#### Licensing Metric

The licensing metric is your staff FTE (academic and non-academic), defined in your HESA return in HE, recorded by the Skills Funding Agency for English colleges or by your national equivalent body for Northern Ireland, Scotland or Wales. NB this may well be different from your Microsoft Campus/EES staff figure – if you are unsure as to your current FTE please contact [howard.moody@chest.ac.uk](mailto:howard.moody@chest.ac.uk)

Your FTE count will remain fixed for the period of the agreement unless it increases by more than 10% from when you joined, then your Institution will be liable for increased fees based on the new FTE count.

The Student FTE is as defined in your HESA return in HE, recorded by the Skills Funding Agency for English colleges or by your national equivalent body for Northern Ireland, Scotland or Wales. ### Agreement Start Date

If you wish to join the agreement then you must return completed paperwork and a purchase order to Chest by July 15<sup>th</sup>. Chest's invoice must be paid by August 9<sup>th</sup>, 2019 without fail – this is non-negotiable, **if you are unable to meet this payment deadline you shouldn't join the agreement.** Please note that these reflect the terms Chest has committed to with Adobe.

All payments for annual renewals must be with Chest by August 9<sup>th</sup> of the relevant year. Chest will invoice you up to three months in advance to give plenty of time for payment to reach us. **Again if you are unable to meet these payment deadlines you shouldn't join the agreement.**

### Change to deployment methodology

Adobe has released Shared Device Licensing (SDL), which is available under this agreement. Serialised deployment is also available, with a serial number that will work through until August 2021. However, serialised deployment will only support up to Creative Cloud 2018. If you wish to deploy CC2019 or certain applications that require a form of named user licensing, you will need to deploy SDL to computer labs/classrooms etc.

### How to commit to join this agreement:

1. Read the terms and conditions of the Master Agreement – if you join you will be bound to the agreement as a “Consortium Member” (Chest is the “Customer”).
2. Complete and sign the Chest ETLA 2018 Commitment Form 2019.
3. Complete and sign the Adobe ETLA 2018 Participation Letter 2019, on your Institution letterhead paper. Please view the Exemplar Participation Letter before completing your copy.
4. Purchase order for the first year’s licence fee. All Purchase orders must be made out to JISC, One Castlepark, Tower Hill, Bristol, BS2 0JA
