### Backfile

#### Payment Terms

##### Ei Compendex

On receipt of a completed Order, Institutions will be invoiced for the Agreement year in which the Licence is signed.

For 3 or 5 year licences in subsequent years, Institutions will be invoiced three months in advance of the anniversary date of the Agreement,

on 8 September 2014, 2015, 2016 and 2017.

Annual licences renew automatically unless an institution opts out by giving notice on or before 8 September 2014, 2015, 2016 and 2017.

3 Year licences renew automatically unless an institution opts out by giving notice on or before 8th September 2017

There is monthly pro-rata charging for Institutions which become licensed partway through a licence year.

#### **Ei Compendex Backfile**

On receipt of a completed Order, Institutions will be invoiced for the full amount of the Backfile as a one-off perpetual purchase fee.
