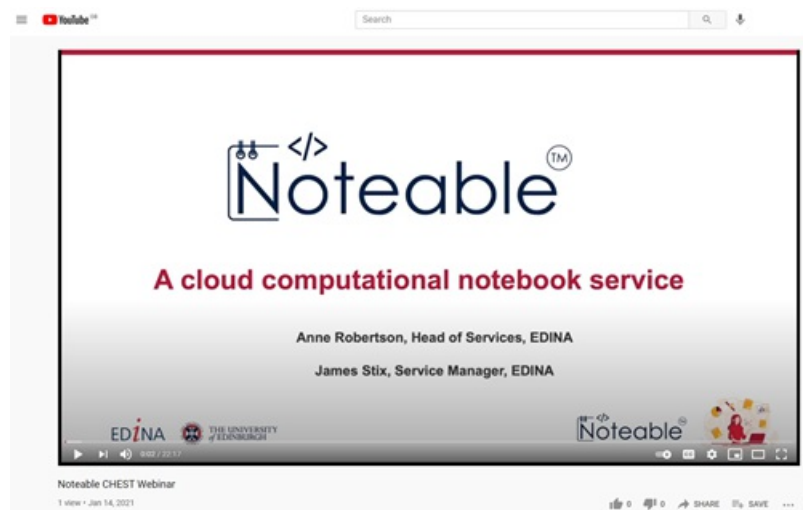

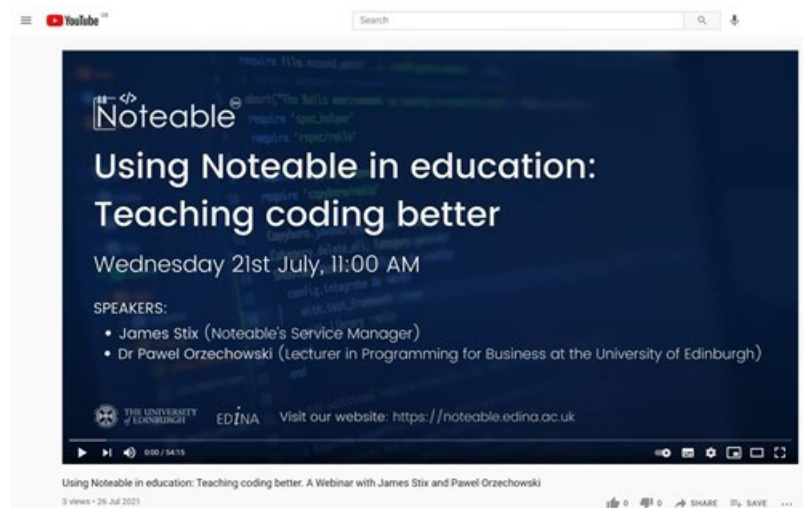

Prerequisite

Access to Noteable requires integration with your institution's Learning Management System / Virtual Learning Environment.

Licence Term

Institutions commit for 1 or 3 years from when they start their licence. The licence start date will determine the pricing, please see the tables below which show the pricing per year in UK Pounds (£s). All prices exclude VAT which shall apply at the appropriate rate.

Per User licence pricing is based on the number of Users, with bands as shown below. **Note that, once allocated to an individual, a Per User licence cannot be reallocated within the licence year.** For sites committing to a 3 year licence this means that you can reallocate Per User licences at the start of years 2 and 3.

Site licence pricing is based on **Jisc Bands** for Higher Education institutions. Pricing for Further Education institutions who are interested in a Site Licence shall be provided by EDINA upon request. The Site licence offers access for up to 1000 concurrent users.
