# **Terms and Conditions**

## **Payment Terms**

Chest is an Enterprise of Jisc. All Purchase orders must be made out to JISC, One Castlepark, Tower Hill, Bristol, BS2 0JA Payments are due within thirty days of invoice date; recipients of late payments are entitled to interest in accordance with UK statutory provisions.

On receipt of a completed Order, and a Purchase Order (if required by the Institution) made payable to Jisc, Institutions will be invoiced depending on the licence and payment term selected. Invoices are payable within 30 days of the date of the invoice.

- For a one-year licence, the invoice will be for the Agreement Year in which the Licence is signed.
- For institutions signing up to three or five-year agreements
  - If they have opted for the annual payment option, they will be invoiced for year one immediately, with invoices for subsequent years to follow approximately three months prior to the licence anniversary date
  - . If they have opted for an upfront payment, Institutions will be invoiced for the whole three- or five-years licence fee immediately
